# 6.1 Speaker's Brief Profile

# Profile of Dr. Arun Kashyap

"Dr Kashyap had his education from Lucknow University and IISc, Bangalore from where he did his PhD in the area of Polymer Science. Had a brief teaching and research assignment at BITS, Pilani for one year before he joined IOCL (R&D Centre) in 1978.

During his stay at IOCL, he had three distinct assignments in the technology areas of

(i) Development of Rail Road Oils and Marine Oils on Component Approach Basis during 1978 to 1985,

(ii) Setting up of Anionic Polymerization & Hydrogenation Laboratory; Developing Viscosity Index Improvers based on the Synthesis of (i) Linear and Star Isoprene Polymers & Copolymers by reactions such as anionic polymerization, block copolymerization and coupling reactions via bench top methodology followed by subsequent Hydrogenation, (ii) Olefin Copolymers by metallocene catalyzed polymerizations and (iii) Polymethacrylates by group transfer polymerization and their Laboratory Evaluation in the formulation of multigrade Automotive Oils during 1985 to 1994 and

(iii) Laboratory Evaluation of Rheology Modifiers such as Pour Point Depressants, Drag Reducers, Wax Dispersants in the Pipeline Transportation of Crude Oils and Middle Distillates during 1995 to 2002.

Dr Kashyap was asked to take up the assignment in the area of Intellectual Property Rights in the year 2002. Understanding & Integration of Various IP Processes to set up an IP Cell became his passion. He is recognized for his role in the Selection of IP Consortium for IOCL through the process of Global Expression of Interest followed by Tendering amongst shortlisted technically equivalent IP Consortiums. Post-superannuation he has been retained by IOCL for 2 years to streamline their IP Cell. He has worked with IOCL till March 2014.

He has been associated with Crafitti Consulting Pvt. Ltd. to look after the NCR area. He has prepared a monograph on Putting back the Indian entities on right Intellectual Property tracks

# Profile of Dr. Rajesh Dixit

Dr. Rajesh Dixit, working as a Deputy Controller of Patents & Designs and Incharge of International Searching Authority and International Preliminary Examination Authority (ISA/IPEA) at Patent Office Delhi. He did his M. Sc. (Chemistry) and Ph.D. from Rajasthan University, Jaipur. He published nearly 20 research Papers in National as well as International Journals. He is also life fellow of Indian Chemical Society, Life member of Indian Science Congress and life fellow of Institution of Chemists (India).He was worked in the Central Fertilizer Quality Control under Ministry of Agriculture and National Test House under Ministry of Commerce before joining the Patent Office. He had nearly 28 years' experience in the Govt. of India. He is a Member of Traditional Knowledge Digital Library Task Force constituted by the Govt. of India to Protect the Traditional Knowledge of India .He is also a core Group member of the Modernization Project of IPOS in India and Visited Japan Patent Office in Year 2002 and 2015,WIPO,Geneva in 2016. He had delivered so many lectures on IPR, Patent and PCT system in India. He had also attended so many International Seminars, Conferences and workshops on IPR.






