SPORTS FINANCE FACTS



- The Indian Premier League (IPL) is one of the most lucrative cricket leagues globally and has a significant impact on sports finance in India. The total value of the IPL after the 2021 edition has been placed around Rs 35950.53 crore.
- The estimated cost of organizing the 2010 Commonwealth Games in Delhi was around ₹70,000 crore (approximately \$9.4 billion), including investments in sports infrastructure and related facilities.
- Indian cricketer Virat Kohli is known for his high-value endorsements. In 2020, he was ranked 66th on Forbes' list of highest-paid celebrities, with earnings of \$26 million, which included endorsement deals.

Major Dhyan Chand, a legendary Indian field hockey player, is often considered one of the greatest sportsmen in history. Born in 1905, he earned his nickname "The Wizard" due to his extraordinary skills and control over the ball.
