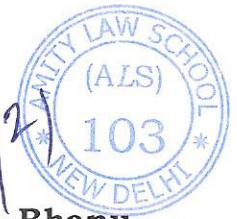
Guidelines for preparation of synopsis for Dissertation (LLB 502)

1. Synopsis to be spiral bound and cover page as per Annexure I
2. Number of pages in the synopsis to be between 12 and 15
3. The synopsis must contain, in strict chronological order
 - i. Introduction
 - ii. Statement of Problem
 - iii. Objectives of Research (3-5 objectives)
 - iv. Research Questions (3-5)
 - v. Survey of Literature (10 sources 5 books/5 articles)
 - vi. Hypothesis /Hypotheses (100 – 120 words in bullet points)
 - vii. Research Methodology (100 – 150 words)
 - viii. Tentative Chapterization (5 chapter)
 - ix. Bibliography / Webliography
4. The citation styles shall be followed as per ALS Research Manual.
 - I. Font - Times New Roman
 - II. Font size – 12
 - III. Spacing – 1.5
 - IV. 01 inch margin on all four sides

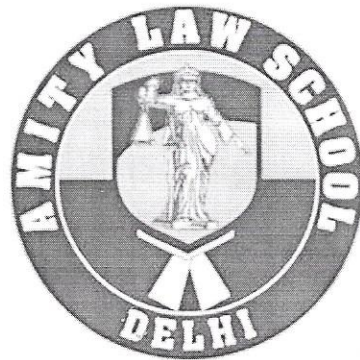
