REPORTING OF CANDIDATES AND VERIFICATION OF DOCUMENTS AND PAYMENT OF BALANCE FEE FOR 2017-18 BATCH AT AMITY LAW SCHOOL, DELHI (AN INSTITUTON OF RITNAND BALVED EDUCATION FOUNDATION) (AFFILIATED TO GGSIP UNIVERSITY)

- 1. This is in supersession of the earlier notification of dated 20^{th} July, 2017 on the above subject.
- 2. As per the notification of GGSIPU vide no. *F.No..IPU-7/Online Counseling/2017-18/22449* dated 21/7/2017, the reporting dates of candidates have been changed from 24th July to 26th July, 2017.
- 3. All the students who have taken admission through GGSIP University for Amity Law School, Delhi are hereby informed that they should report for verification of documents and payment of balance fee at Amity Law School, F1-Block, 1st Floor, Amity University Campus, Sector-125, Noida from 24th July 2017 to 26th July 2017 from 10:00 am to 5:00 pm as per seclude given below:-

In addition to the fee of Rs. 40,000/- already paid to the IP University, the students are required to pay an additional amount of Rs. 41,400/- (Rupees Forty One Thousand and Four Hundred only).

The fee should be paid through a Demand Draft in favour of <u>AMITY LAW</u> <u>SCHOOL</u> payable at <u>DELHI</u>.

- 5. ALL CANDIDATES SHALL BRING ALL ORIGINAL MARKSHEETS & PASS CERTIFICATES FOR X & XII, CERTIFICATE FROM 10TH (OR EQUIVALENT) ONWARDS FOR VERIFICATION. TWO SETS OF PHOTOCOPIES OF SELF ATTESTED MARKSHEETS AND CERTIFICATES TO BE SUBMITTED AND SHALL BE RETAINED BY THE COLLEGE. IN THE ABSENCE OF MANDATORY DOCUMENTS OF PROOF OF ELIGIBILITY FOR ADMISSION IN B.A.LL.B (H) PROGRAMME, THE CANDIDATURE SHALL BE CANCELLED.
- 6. IN CASE OF STUDENTS WHO HAVE PASSED THE QUALIFYING EXAMINATION THROUGH DISTANCE/OPEN EDUCATION SYSTEM OF ANY RECOGNIZED UNIVERSITY/ BOARD/ INSTITUTION, THE NECESSARY DOCUMENTARY EVIDENCE RELATED TO LOCATION OF HIS/HER STUDY CENTRE I.E. STUDY CENTRE PROOF, CERTIFICATE FROM THE UNIVERSITY IMPARTING OPEN/ DISTANCE EDUCATION CERTIFYING THE LOCATION OF THE STUDY CENTRE.
- 7. CONDUCT AND CHARACTER CERTIFICATE IN ORIGINAL FROM THE HEAD OF THE INSTITUTION FROM WHERE THE QUALIFYING EXAMINATION HAS BEEN PASSED OR FROM A GAZETTED OFFICER (ORIGINAL), NOT MORE THAN 6 (SIX) MONTHS OLD.
- 8. IN CASE, THE RESULT OF QUALIFYING EXAMINATION IS AWAITED, THE CANDIDATES NEED TO SUBMIT THE UNDERTAKING TO THAT EFFECT.
- 9. MEDICAL CERTIFICATE (ORIGINAL FORMAT OF GGSIPU)
- 10. 3 PASSPORT SIZE PHOTOGRAPHS
- 11. 3 STAMP SIZE PHOTOGRAPHS
- 12. FAMILY PHOTOGRAPH (LATEST)
