- 3. The students are requested to write their previous internal marks including PSDA, if applicable, along with the valid email id and mobile number in the registration sheet.
- 4. In case of 2nd and 3rd year(2016 & 2015 batch), the new PSDA projects to be submitted for the respective subjects for which they wish to register for re-appear examination
