CLARIFICATIONS FOR ANMC 2019

1. Para 3 states the relevant provisions of the Security and the Solidarity Act (2018). However, the provisions with respect to the jurisdiction of the said Act and the adjudicating authority for the same has not been provided. What are the relevant provisions for the jurisdiction and the adjudicating authority?

2. What is the content of the media reports in Para 3 which the Government in its press note alleges to be fake? What are the relevant media reports or any relevant paragraphs that can be quoted from such reports?

3. In Para 22, what are the 'oral and documentary evidences' presented before the Trial Court on the basis of which they convicted Ms. Helana Mallaya?

4. In Section 1 of the Security and the Solidarity Act (2018), the phrase 'within 60 days of the general election' in literal meaning indicates the period of 60 days after the general elections. Is that the intention of the problem framer/legislature while enacting the Act? (because this seems contradictory to the purpose with which the Act was brought into force)

5. What are the relevant cyber laws which govern media platforms like 'Instapost' in Latveria? What all is considered as 'publication' under the Latverian law?

Are there any Latverian specific news reports or publication made before regarding the same? If yes, what are their specific names?
