ONLINE INTERNSHIP GUIDELINES FOR STUDENTS (BATCH 2017 & 2016)

Reference to the GGSIP University Revised Academic Calendar 2019-20 dated 5th May 2020, ALS, Delhi Notice dated 6th May 2020 and Notice dated 18th May 2020.

1. All the students must know that the Internships during B.A.LL.B (I.) program carry very vital importance. In present context, where the students are required to go for Online Internship, the provision for such Internship is given in their syllabus with paper code Paper Code 38451 & 38551 for 4th year & 5th year respectively. This Summer Internship with comprehensive viva provision under the afore mentioned paper codes carries 100 marks with 05 credit. Hence like other courses, students are required to take it up with utmost sincerity.
2. A notification of allotment of the students who have applied for Online Internship to ALSD shall be issued shortly.
3. The whole one-month Online internal Internship program has been classified into four parts keeping in view the various training activities/ Practical working assignments.
 - A. **Part 1-** This part consists of number of practical working assignments (3-4) to be assigned to the trainees (students) by the faculty trainer in consultative mode. Meaning thereby a student may give his/her area of interest of law practice to the faculty trainer. However, the decision of faculty trainer for allotment of the assignments to a student shall be final. Students are required to submit assignment together.
 - B. **Part 2-** In this part the experts in the field of law practice shall be requested to deliberate upon clinical wisdom of practice of law along with technicalities of law and lawful tactics and tricks. In this part, the thrust is to give the learning exposure to the trainee of law practice in Court of law. All trainees are mandatorily required to join the online lectures/webinars/, workshops &

various pleadings etc (at least four). Further, in order to ensure the efficacy of online Internship, the trainees are required to make attachments of screenshots of their registration and joining-patch to be submitted along with the below mentioned write ups in spiral form for evaluation. Moreover, all trainees are required to prepare write ups on what is ***Deliberated, Discussed and Directed (3D) in these online deliberations.***

C. **Part 3-** All trainees are required to prepare a document on the following aspects:

- Practical aspects of recent Ordinances/Amendments in Labour laws or any other law.
- Practical side of section 144 of CrPC,
- Law as an instrument in preventing the spread of COVID-19,
- Legal practical aspect of NDMA (National Disaster Management Authority).

D. **Part 4-** This part is choice-based.

- All the trainees with their free choice shall work upon on any prevalent issue through '*client counseling*' (this has to be done with the knowledge and guidance of the faculty trainer).
- All student shall prepare a write-up (08 - 10 pages) of practical aspects of law in this part.

Note :- *The above works (all four parts) must contain 45 to 55 pages. Annexure/s, Specimen copies and other learnable docs etc. are excluded.*
