• All selected papers will be published as Conference Proceedings with an eISBN Number, subject to copyright form duly signed and submitted after acceptance of the paper. Upon acceptance of the paper, the author(s) agree to the following:

(a) to release the copyright to the ICESBD 2022.

(b) to return the manuscript in correct format (via e-mail) to the Proceedings Editor.

(c) at least one author will present the manuscript at the conference and will pre-register as a condition for acceptance and publication.

- Only selected papers chosen by the review committee will be published in either partnered journals or edited books based on the review process.
- Recommended papers will be published in:
 - Journals of repute (Scopus/ABDC/UGC Care Listed)
 DYNAMIC RELATIONSHIPS MANAGEMENT JOURNAL (SCOPUS)
 - An edited book with a renowned international publisher Apple Academic Press based on the quality of the paper.

SUBMISSION GUIDELINES

- An abstract of the paper should not be more than 250 words with 3 to 5 keywords.
- Manuscripts will be accepted in .doc or .docx format only through email on an attachment. The main body of the e-mail message should contain the title of the paper and the names and addresses of all authors. A cover page should accompany the manuscript and include all contact information for all manuscript authors (affiliation, postal address, email address, and phone number).
- Manuscript should report original, previously unpublished experimental or theoretical research results. Manuscript submitted to the conference must not be under consideration for publication elsewhere.
- The length of manuscript should be between 3000 to 6000 words (including the abstract, figures, tables, and references) and appear in Times New Roman font, 12 font size, double spaced with margin of one inch (2.5 cm) on all four sides and justified.
- > The full should cover the following aspects:
 - a. Title of the paper
 - b. Introduction
 - c. Literature Review
 - d. Methodology adopted
 - e. Data analysis
 - f. Conclusion
 - g. Implications- Research & Practical
- Endnotes and footnotes should be avoided. Substantive comments should be integrated within the text rather than placed in a note.
- References should be written in APA style of referencing. All manuscripts would undergo a double-blind peer-review process. Manuscripts should be stripped of identifying information of the author and co-authors.
- A duly signed certificate of originality of paper(s) and separate copyright format shall be obtained from the author(s) of selected papers as per the requirements of the respective journal at the time of notification of acceptance of the paper(s).
