MINUTES OF THE MEETING**

1. The University IQAC meeting for the quarter Jan to March 2021 [III Quarter] was conducted from 31 March to 02 April 2021 (3 days) on Hybrid Mode. Prof (Dr) Balvinder Shukla, Chairperson University IQAC and Vice Chancellor, AUUP chaired the meeting. The list of participants attended the meeting in personal /online and for those leave of absence was granted is attached as **Appendix 'A'**.

DAY 1:- Wednesday, 31 March 2021

2. **Welcome Address By The Vice Chancellor, AUUP** - At the outset the Vice Chancellor, AUUP welcomed all participants present on offline/online mode. She briefed on how the Amity University completed session as per calendar and implemented the 10 UGC Quality mandates. The University also organized more than 2000 webinars with highly eminent speakers and a seminar on NEP 2020. She complemented the University officials for having worked hard to comply with requirements of NAAC, NIRF and other rating, ranking and accreditation agencies. She also set the benchmark of A++ Grade in NAAC and encouraged all present to work towards this goal.
3. Almost all processes have gone online because of the prevailing pandemic situation. This was made possible because of timely technology support provisioned and provided by our Hon'ble Chancellor. AUUP was able to maintain the academic calendar, at a time when most of the university's academic calendar was impacted by the pandemic. With the help of our robust ICT infrastructure and relevant contractual infrastructure, examinations were successfully conducted online and the result were declared timely. The new session for first year commenced late as the CBSE results and results of other universities were delayed. Convocation was conducted in December 2020 on online mode and the degrees were dispatched to the graduands through post. During this period AUUP successfully implemented 10 Quality Mandates issued by the UGC and have uploaded the implementation plan on University activity monitoring portal of UGC.

After these opening remarks, she requested Dr. W Selvamurthy, Dr. Gurinder Singh, Dr. Sunil Dhaneshwar and Dr. N Ramachandran to brief progress in their respective domains / campuses.

4. **Remarks by Dr W Selvamurthy, President ASTIF** - Dr W Selvamurthy gave a presentation on Research, Patents and Technology Transfer progress of the University in the year 2019-20 and 2020-21.
5. Dr Selvamurthy gave an overview on research achievements during the pandemic situation. He thanked Hon'ble Founder President and the Chancellor for providing all the support and motivation. He complemented the faculty members of AUUP, Noida and sister campuses for achievements like sanction of research projects, more than 2500 Scopus research publications, patents, technology transfer, collaborative partnerships, creation of research clusters during the pandemic. He concluded that all this was possible only with commitment and devotion of all faculty members and staff of Amity University.
6. **Remarks by Dr Gurinder Singh, Group Vice Chancellor & Campus Head, Greater Noida**- Dr Gurinder Singh, highlighted the development on Internationalization and achievement of Greater Noida campus. He said that through the efforts of faculty and support of senior management at Apex level, the world is recognizing Amity among the top universities of world.
7. He further spoke about establishment of world Class University at Tashkent and said that It's also great pleasure for us that government invited us to open a campus with zero investment. The University will be adding various innovative courses / programs like Artificial intelligence, Block Chain management, Data Science, Machine Learning etc in Taskhkent Campus.
8. The Management is working hard to create Global Research Hub at New York Campus involving best scientific minds of the world. The University has established linkages with many foreign universities like Princeton University, Harvard University etc. The international conference organized there attracted 486 senior faculty members from prestigious universities.
9. **Remarks by Dr Sunil Dhaneshwar, Pro VC Lucknow** - Dr Sunil Dhaneshwar briefed the house about achievements of Lucknow Amity campus. He said that Lucknow campus could adhere to academic calendar during the pandemic. Faculty members are engaged in publishing Research papers, books and books chapters. Approx. 500 papers are published out of which 135 were in Scopus indexed, 44 in Web of Science and remaining are in UGC approved Journals. 65 Projects have been submitted for funding out of which two have been sanctioned. 6 patents have been filed out of which one is granted.
10. Conducted more than 200 webinars during this period by inviting scientists and eminent people from the world. One international conference was conducted by Engineering and Technology Domain wherein 16 international speakers took part on online mode.
11. **Remarks by Dr N Ramachandran, Pro VC Dubai Campus**-Dr Ramachandran, briefed the house about the achievement of the faculty and students of Amity Dubai campus. He informed

that a funding of 216000 US dollars has been received from UAE Space Association for establishing their Satellite ground station in Dubai Campus. One important project of engineering department (treatment of ablution water) is also funded by EXPO 2020. More than 200 Scopus indexed research papers were published by the faculty.

12. Member Secretary University IQAC & Dean AQA, briefed the house about the agenda points of the III University IQAC Meeting.

**Presentation:** Dr Alpana Kakkar, Dy DSW along with Mr Sujit Prasad, COE presented institution wise and campus wise status of students who had registered for Guided Self Study Courses (GSSC) for the year 2019-20 & even semester 2020-21.

The presentation covered number of students registered for GSSC, percentage of students permitted and not permitted to appear for the examinations.

Comments of External Expert:- Dr Yogendra Narain, enquired whether any students were not permitted to take GSSC due to nonpayment of fees.

The COE clarified that no students was barred from taking GSSC due to non-payment of fees during the pandemic.

**Concluding Discussion:** The data should be presented in a more meaningful manner, graphs should be separate for Permitted Students and Not Permitted Students so that some action items could be discussed after the presentation.

**Presentation:** Dr Alpana Kakkar presented an overview of the interventions into slow and advanced learners in the Even Semester 2020-21. This was followed by presentations by Deans Faculty of Studies for their respective domains. The focus areas of the presentation were:

1. Basis of identification of slow and advanced learners
2. Activities undertaken to support slow learners
3. Activities undertaken to support advanced learners
4. Institution wise data within respective domains.

Comments by the external expert : Dr Yogendra Narain gave the following suggestions:

1. Language also sometimes acts as a barrier for slow learners. University may like to consider interventions to overcome this barrier.
2. University may consider having separate sections for slow learners.

**Concluding Discussion:** Vice Chancellor said that institutions have identified slow and fast learners broadly based on proficiency test at the time of admissions and end term result during the conduct of the course. There is a need to relook into this practice. The students should ideally be identified based on the continuous assessment of students by Faculty and the action taken by the faculty should be kept as evidence. Being weak in specific subject is different from being a slow learner. The support system should be such that we are able to bring slow learners apace with expected levels of learning. For Advanced learners such opportunities should be provided that they are able to achieve honors and awards at national and international level.

**Presentation:** Dr RS Rai, Director – Research Planning & Statistical Services gave a presentation on impact of student progression on rankings in NIRF, ARIIA, and NAAC accreditation with respect to weightage given by these bodies to student participation and achievements in various activities at different levels, examinations, placement, startups, higher education and competitive examinations.

Dr RK Kapur, Director Academics discussed the evidences required to be uploaded on Amizone for student progression, status of institutions that have uploaded the data and anomalies found on the data already uploaded by institutions. He also shared institute-wise status of student progression viz-a-viz the aspiration survey of these students.

Following evidences are required to be uploaded on Amizone:

1. Evidences for Placement – Copy of appointment letter.
2. Family Business – Copy of offer letter for family business
3. Higher Education – Copy of offer/admission letter
4. Competitive Exams/Professional Qualification – Copy of admit card/Result
5. Starting Own Venture – Name of venture, Name of the supporting pre incubation unit of AUUP, Registration details, Name and DIN number

Following Anomalies were found in uploaded data:

1. Incomplete evidences
2. VDS forms uploaded for higher education, family business, own venture, competitive exams.
3. Internship letters for placements
4. E-mail, interview letters, list of shortlisted students, copy of salary cheques, performance report

Comments by the external expert: Dr Vijay Malik pointed out that the numbers mentioned against each category is a combined figure of self-placed and placed through AUUP; she suggested that the data be segregated accordingly.

**Concluding Discussion:** Vice Chancellor pointed out that data of total student's eligible for placements and the progression does not match with the aspiration survey. At some places progression is much higher than the aspiration survey. This needs to be corrected and further analysis has to be done in terms of student aspiration, support provided by the institution and final status of progression against the support provided. Data should also be presented in percentage against passing out students.

In most of the institutions the number of students who have joined family business or started own venture is more than the data given in aspiration survey. From the data provided it appears that students who have either not been placed or not gone for higher education have joined family business or started own venture. Therefore, it is important to ensure correctness of evidences submitted and uploaded on Amizone. All Deans of faculty will require to analyze the data submitted by institutions under their domains and have the evidences thoroughly checked for correctness.

Dr Kapoor suggested that since the student aspirations keep changing the aspiration survey should be updated at the beginning of final year.

**Concluding Discussion:** The Vice Chancellor said that the implementation report should highlight the domains /institutions/ programmes that have not been able to attain the planned outcomes fully, reasons for the same and changes suggested to be made in the assessment method for the next academic year. Also, mapping of PLOs to be done with Graduate Attributes and results of Direct

**Presentation:** Criterion Co-Chairpersons Dr M Sajnani and Dr RK Kapur gave the presentation as per AQAR format for Criterion 1.

**Concluding Discussion:** The Vice Chancellor, AUUP said that with respect to metric 1.3.1, the SOP must be referred to while listing the Value Added Courses. According to the SOP, only those value added courses are to be considered which are optional and offered outside the curriculum of the programs. Brochure and Course content or syllabus along with course outcome of Value-added courses offered are to be uploaded. Also, courses which are part of programme structure cannot be considered as part of this metric.

The Vice Chancellor also said that evidence for all metric of Criterion 1 should be made available on Amzone. For example in metric 1.3.2, where the data for number of students undertaking field projects/internships have to be mentioned, copies of the project sanction, internships and certificates to be uploaded.

**Presentation:** Vice Chancellor informed the house that Criterion 2 was earlier chaired by Dr Alka Munjal and has been recently handed over to Dr VJ Byra Reddy. Criterion Chairperson gave the presentation as per AQAR format for Criterion 2.

Comments by External Experts:- Dr Yogendra Narain wanted to know that how the students teacher ratio and mentor mentee ratio is the same.

The Vice Chancellor replied that in Amity we have mentoring system in which all faculty mentor students therefore both ratios appear same.

Dr Vijay Malik also raised the query that that in metric 2.5.2 percentage of student's complaints regarding evaluation has been increased from 2.33% (2018-19) to 2.89% (2019-20), is any root-cause analysis has been done to know the cause.

Dr Sanjeev Bansal, clarified that the reason for increase in the complaints was due to the change of conduct of examination to online mode.

**Concluding Discussion:** Vice Chancellor, AUUP directed that with respect to metric 2.4.1 regarding the sanctioned post, the HR must update the sanctioned post for the year 2019 – 2020.

**Presentation:** Criterion Chairperson Dr W Selvamurthy gave the presentation of AQAR for Criteria 3.

**Concluding Discussion:** Vice Chancellor, AUUP said that the data was not presented in the AQAR format and the evidence for all the metrics should be produced as per the SOP and data template. Comparison of AQAR of 2018 - 2019 and 2019 - 2020 was not presented. Analysis of all the metrics to be conducted so that we improve our performance. Dr Gurinder Singh suggested that feedback from the research scholars should be taken to analyse the reasons for delay in award of PhD. The Vice Chancellor suggested to check the quality of PhD thesis at institutional level, so that the numbers of thesis being rejected can be minimized. Corporate training figures needs to be rechecked. Data needs to be cross checked with NIRF Ranking and Atal ranking, with Dr R S Rai. Evidence as per SOP is required to be submitted for all the metrics.

**Presentation:** Criterion Chairperson Rear Admiral RC Kochhar gave the presentation as per AQAR format for Criterion 4.

Comments by the External Experts – Dr Vijay Malik advised to match the total expenditure incurred and the budgeted statement. The budget augmented/ utilized/ spent needs to be matched and supported with documentary evidence for scoring full marks in the metric.

**Concluding Discussion:** The Vice Chancellor, AUUP cleared that the financial statement of budget utilization, income and expenditure of infrastructure development, augmentation, maintenance of physical facilities and academic support facilities to be produced to support the data. Score to be mentioned metric wise, which indicates the continual improvement from the last year. Metric 4.1.1 Budget allocation excluding salary needs to be cross checked as it is on decreasing trend. Metric 4.1.2 - Virtual labs not to be mentioned in 2019 - 2020. It needs to be mentioned in 2020 - 2021. Upgraded Labs needs to be mentioned - Existing labs which are upgraded needs to be mentioned in metric 4.1.2.

The data for Library resources are not matching with the total amount given for the previous and current academic year. The data for Library services needs to be cross checked with Finance Department.

The data for E -content developed needs to be checked and updated. The column of platforms should be checked by the IT Department. She said that the data needs review and rechecking by all the process owners.

**Presentation:** Vice Chancellor informed the house that Criterion 5 was earlier chaired by Dr Alka Munjal and has been recently handed over to Dr RS Rai. Dr RS Rai presented the status of AQAR 2019-20 for criterion 5.

**Comments by External Experts:-** Dr Vijay Malik pointed out that one of the unresolved grievances is pertaining to sexual harassment which is a serious matter.

Dr Vijay Malik also pointed out that the Number of participants in 5.2.1 with respect to student placement have been left blank. The correct figures may be filled. Student participation in various cultural activities organized at the university or institutional level appears to be too high. There is a need to recheck this for correctness.

**Concluding Discussion:** Students benefited by guidance for competitive examinations and career counselling, still remains a weak area as we have not been able to capture evidences appropriately. There is a need to strengthen the mechanism for capturing this data with evidences.

Regarding student placement metric 5.2.1 Vice Chancellor said that the annual report for placement needs to be prepared which is not complete as institutions have not submitted complete data. Institutions must submit complete data with correct evidences.

Dr Rai suggested that in order to capture progression details of passed out students there is a need to have a better mechanism to connect with alumni. Vice Chancellor directed to plan an alumni felicitation function for alumni special achievements. Alumni would be required to submit their credentials for the function.
