21ST University IQAC Meeting 30 January and 1 February 2023 Minutes of the Meeting

The 21st University IQAC meeting was conducted on 30 January and 1 February 2023 under the Chairpersonship of Prof (Dr) Balvinder Shukla, Chairperson University IQAC and Hon'ble Vice Chancellor, AUUP.

- 1. After ascertaining the quorum for the meeting, Dr R S Rai, Director IQAC, started the meeting with the permission of Chair and welcomed all the members of the University IQAC.
 - **1.1** Opening Address by the Chairperson University IQAC At the outset the Chairperson University IQAC & Vice Chancellor, AUUP welcomed University IQAC members, external members, alumni members and all those present in the meeting.

She apprised the house that during the year 2023, the IQAC needs to gear up for two prestigious accreditations i.e. NAAC 3rd cycle re-accreditation and QAA (UK) re-accreditation. Both the accreditations are very intense, and evidence based. Each metric must be read in conjunction with the requirement of the metric, its Standard Operating Procedures (SOPs) and Data Templates to be prepared ads per NAAC guidelines.

The major achievements of the University during the three months (Nov-Jan) are given below:

- ➤ Amity University has been selected by IEEE UP Section for "Educationalist of the Year Award" (Institutional) 2022 in recognizing contributions towards the motto of IEEE, "Advancing Technology for Humanity".
- "Amity University Student Branch of IEEE (STB07271)" has been awarded as second prize by IEEE UP Section for "Activities Based Branch Incentive Award 2022".
- ➤ "Amity University Student Branch of IEEE (STB07271)" has been selected as winner by IEEE UP Section for "U10 Initiative 2022".
- ➤ The University showcased its path-breaking Research and Innovations at 8th India International Science Congress IISC-2022, organized at MANIT Bhopal. Amity' stall was visited by over two thousand people every day. Over 40 researches and innovations by Amity Scientists were on display like HnB9 foundation A novel phosphate solubilizing fungal biofertilizer, Rootonic-symbiotic fungus promoting increased yield in plants, portable water purifier, herbal remedy for Psoriais, etc.
- > Amity Centre for Translational Research (ACTR) established on 19 January to facilitate clinical research for managing life style associated diseases.
