Agenda:

- 1. To discuss about the syllabus of ABS programmes (BA (H) Economics and MA Economics) offered at ABS.
- 2. To discuss about the change in credit hours of teaching.

During the meeting following points were discussed/ reviewed:

•1. Review of Syllabus and suggestions for improvement: With the objective of imparting: (i) knowledge of fundamental concepts and theoretical propositions, (ii) a methodology by which economic ideas are framed, tested and modified, (iii) an understanding of the institutions, social, political and economic that influence economic issues, and (iv) an ability to present one's own

analysis of the problems and issues in the language of an 'Economist', the syllabus of BA (H) Economics programme and MA Economics programme were reviewed and suggestions were made to update topics that are of current relevance.

- 2. Change in Credit Hours: Considering the research oriented approach to course delivery and also to standardize with similar programmes of other universities, the credit load of M A Economics Programme has been reduced from 130 credits 100 credits. Curriculum of the courses where credits are reduced have been reviewed comprehensively. Duplication of content in similar courses are also reviewed and the following changes have been recommended:
 - a. The credits of following courses to be reduced in line with their remarks: (Refer-Ann-1)
 - b. Changes have been incorporated in the syllabi by adding contemporary topics in the subjects with a view of providing the state of art education to the students. The percentage change made in the syllabi of different subjects varied from 5.8 percent to 11.6 percent. (Refer-Ann-2)
 - c. Comparative programme structure of old and new is attached as Ann-4

In last, the Chairperson appreciated the efforts put in by the members during the discussion and expressed her thanks to all.
