Acceptance/rejection notification will be sent within one week of the abstract submission deadline.

Accepted full papers will be published in an edited book published by Springer, the International Journal of Business and Data Analytics (IJBDA), or the MTMI publication: [Review of Business and Technology Research \(RBTR\)](#). It is assumed that the paper submitted is author's original work and have a similarity index (8 words count) below 20%. The published papers in the RBTR will have copyright of MTMI. The final paper in template must be submitted by the deadline to be included in the book published by Springer, IJBDA, or the RBTR.
