# A MEMORANDUM OF UNDERSTANDING ON "INDUSTRY – ACADEMIA COLLABORATION"

Of Madhya Pradesh is recognised as per Section 2(f) of the UGC Act located at Gwalior hereinafter called as First Party, which expression shall include their respective successors and permitted assigns unless the context otherwise requires

### JLJ Law Offices, New Delhi

Founded with a visionary motto "Just Law and Justice" is a full-service law firm providing legal services across the country in various fields of law and having its head office at New Delhi hereinafter called the Second Party, which expression shall include the respective successors and permitted assigns unless the context otherwise requires

#### 1. Scope

AU MP and JLJ Law Offices hereby agreed to explore opportunities for industry cum academic collaboration to their mutual benefit. Nothing in this Memorandum of Understanding shall be construed as creating a legal relationship between the two parties.

#### 2. Proposed Developments

Both Institutions intend to develop industry – academia collaborations on the following:

- (a) AU MP will give JLJ Law Offices a preferential treatment when holding campus recruitment sessions.
- (b) **AU MP** will make arrangements for progression of suitably qualified BA/BBA/BCom LLB and LLM students of AU MP for next level of Internships / Retainership and Associate positions at JLI Law Offices.
- (c) AU MP will regularly invite Senior Management Team and Experts of JLJ Law Offices for giving lecture on law related topics and any other legal activities etc.

- (d) **AU MP** will ensure that the student participating in terms of the present agreement should perform to the best of their capabilities and execute the tasks assigned with utmost sincerity and within time.
- (e) **AU MP** will ensure to offer the most desirable, efficient, committed and academically bright students for the purposes of internship and placement to JLJ Law Offices.
- (f) All the pecuniary implications and expenses incurred will be taken care and handled by AU MP in order to execute and implement the objects and purpose of the present agreement and JLJ Law Offices will not have any pecuniary and/or financial implications in any manner what so ever in respect of the present agreement.
- (g) **JLI Law offices** will invite AU MP's students for their Industrial Training, Internships etc in their sixth, eight and tenth semesters of law curricula.
- (h) JL Law Offices will guide and supervise (if required) AU MP in introducing new courses and designing their content towards making the students industry-ready.
- (i) JLJ Law offices will support AU MP in conducting various Moot Courts, Seminars and National Law Conferences.
- (j) JLJ Law Offices will be engaged with AU MP's Law Professors in the curriculum development, consultancy and research related to Law Domains.
- (k) JL Law Offices will provide assignments for legal research and drafting of ongoing cases to the students of AU MP within campus from time to time so as to provide real time exposure to the students of AU MP.
- (I) The internship and placement opportunities will be provided by JLJ Law Offices subject to the availability and also the student of AU MP being duly satisfying the criteria of both the internship and placement as decided by JLJ Law Offices from time to time.
- (m) JL Law Offices will not be responsible for any kind of misconduct and/or misbehavior and/or indiscipline acts of the students doing internship and/or absorbed through placement with JL Law Offices and that the JL Law Offices will have the right to immediately terminate the internship and/or the placement of any such student without prior notice.

### 3. Duration of the Memorandum of Understanding

- i. This Memorandum of Understanding is initially valid for three years from the date of signature of the authorized representative of the organisations. At the end of three year period it will be considered by both the parties for renewal.

- iii. This Memorandum of Understanding will be reviewed annually and may be terminated by either party at any time without any prior notice through written communication on email. The ongoing activities will not be affected with the termination till the completion of the activity.
- iv. Arrangements shall be made for both organizations to ensure adequate contact, communication and the exchange of information to enhance the understanding.
- v. Both the institution being party to the present agreement will make best of endeavours for just and proper execution of the present agreement.
- vi. Both the parties can make public the information with regard to the present association through media and/or any other mode of publication (private or public) including their website etc.
