1. Scope

AUMP and LMI INDIA Pvt. Ltd. hereby agreed to explore opportunities for industry cum academic collaboration to their mutual benefit. Nothing in this Memorandum of Understanding shall be construed as creating a relationship between the two parties.

2. Proposed Developments

Both Institutions intend to develop industry cum academic collaborations on the following:
