- iii. To establish a special purpose vehicle to promote researchers and innovators, identify potential collaborators from industry, research organizations, academic institutions & other stakeholders for cooperation and synergistic partnerships.
- iv. To act as a liaison between researchers & relevant research funding agencies, extend guidance in preparation & submission of project proposals and post-sanctioning of the grants to oversee adherence to timelines.
- 4. The guidelines issued by UGC is attached for ready reference to all the members of RDC.
- 5. This re-constituted of Research and Development Cell (RDC) will function w.e.f the date of issue of this notification. The previous notification issued vide Office Ref No. AUMP/RO/2022/148 dated 11.04.2022 stands cancelled with the issue of this notification.
