



Guidelines For Ph.D. Course Work

1. As of now the Ph.D. coursework is of 12 credits as follows:
 - i) Research Methodology – 4 Cr.
 - ii) Review of Literature – 2 Cr.
 - iii) Research and Publication Ethics – 2 Cr.
 - iv) Broad area of research having one paper – 4 Cr.
2. All the HoI have recommended the one core paper of broad area of research that should be specific concerning the particular field in which the research scholar will undertake his / her Ph.D. The papers will be of 4 credits.
3. In view of the above all the HoI / HoD / Supervisors should design specific syllabus pertaining to his / her topic of the research area after SRC. This is required to be approved by Hon'ble VC on behalf of BOS subject to final approval in the next meeting of BoS of the respective Department / Institute.
4. Accordingly for the ESE customized question paper should be sent for each individual research scholar from the course he / she has opted.
5. SRC / DRC should decide the topic / supervisor of the optional specialized paper in consultation with the student's right after the orientation programme and before the commencement of course work classes.
6. The review of literature of Ph.D. course work is of 02 credits and students are required to write the same on their own in consultation with their respective supervisors. This should be treated just like other non teaching credit course (NTCC).
7. Students should submit the review of literature in 03 copies by the due date as per academic calendar. It should be forwarded by HoI / HoD to Dean Research for onward submission to CoE for evaluation.
8. It is hereby emphasized that the quality of review of literature should be of high standard and needs to be published in Scopus / SCI Journal as a review paper by the end of 1st semester.


