- c. To challenge students to excel in law, consequently testing their creativity and powers of persuasion in a friendly competition.
- d. To provide an opportunity for the students to interact with their counterparts of entire country at one place.
- e. To motivate the students to excel in their wings of creativity, specifically in the field of law.
- f. To create an atmosphere of Moot Court in the ALS.

Hon'ble Mr Justice Rajendra Menon (Retd),

Recognitions & Awards

Born on 7th June 1957 in Mannarkkad, Distt- Palakkad, Kerala. Had School education from Christ Church Boys Sr. Secondary School, Jabalpur. Passed Sr. Secondary School Examination in 1974, thereafter, graduated in Science from Govt. Science College, Jabalpur under Rani Durgawati University (Jabalpur), did

L.L.B from NSE Law college (Jabalpur) in the year 1981. Started practicing Law soon, thereafter, was associated with Sr. Advocate P. Sadashivan Nair and Mrs. Indira Nair, Sr. Advocate and was Standing Counsel for Central Government from 1991 till his elevation to the Bench in the year 2002, besides had been Standing

Counsel for several Private and Public Sector Undertakings like Coal India Ltd., Syndicate Bank, Union Bank of India, Vijaya Bank, Rani Durgawati University, M.P.Dairy Development Corporation, Associated Company Ltd., Reliance, Tata Motors and various other establishments.

Took oath as Additional Judge of Madhya Pradesh High Court on 01.04.2002 and became Permanent Judge on 21.03.2003. Was posted at Gwalior Bench of the Madhya Pradesh High Court till March 2008, thereafter, got posted at the Principal Bench, Jabalpur. Was acting Chief Justice of Madhya Pradesh High Court from 13.05.2016 to 14.03.2017. During the tenure at Madhya Pradesh High Court, was associated with several administrative committees. Was also appointed as Welfare Commissioner for the Bhopal Gas Victims Compensation Commission during the period December 2010 to March 2015, Was also incharge of Judicial Education & Training and Chairman of M P State Judicial Academy and Chairman of M P State Legal Services Authority from March 2015 till 14th March 2017

Elevated as the Chief Justice of Patna High Court on 15th March 2017 and remained as Chief Justice of Patna High Court till 7th August 2018.

Sworn in as Chief Justice of Delhi High Court on 09.08.2018, Retired on 06.06.2019.

Appointed as Chairperson of the Armed Forces Tribunal, on 6th November 2019.

Maj General P.K. Sharma

Recognitions & Awards

- 1. Maj Gen PK Sharma (Retd), a fourth generation Lawyer, is an alumnus of Rajasthan University Jaipur, having acquired his Degree in Law in the year 1978. He also holds a Post Graduate Diploma in Information Technology and Post Graduate Diploma in Human Rights. He was commissioned in the Judge Advocate General's Department of the Army on 30 August 1980.
- 2. An astute and result oriented Army General, he rendered 'Judicial Service' of nearly 35 years in Military Justice System. While serving in the Indian Army, he developed abilities to conceptualize, develop and execute plans that require precise actions and utilization of available resources. He has tremendous experience in the domain of legal and judicial functioning, General Administration and Legal Training. As Judge Advocate General (JAG), hewas the legal advisor to Chief of the Army Staff on all disciplinary matters, service conditions, issues involving application of Civil, Military and International Laws and entire litigation relating to the Army. General Sharma was in the Raising Team of the Institute of Military Law, Kamptee (now shifted to New Delhi), a premier Category 'A' Institute, the only one of its kind in Asia, training Officers of Indian Army, Navy, Air Force, BSF and even foreign Armies, in the field of Law. He superannuated as the Judge Advocate General (JAG) of the 1.4 million strong

Indian Army on 31 May 2015 and joined as Director Amity Law School, Gurugram on 01 Sep 2015.

- 3. As Director Amity Law School, he has endeavored to bring up the nascent institute at parwith leading Law Schools across the country. General Sharma has ensured academic excellence among the students and a research-oriented attitude in the Law School. Towards achieving this goal, he has been instrumental in organizing National level Moot Court Competitions and International Conferences of high repute. Under his expert guidance, the Law School commenced publishing a news-based Journal Amilawyers and ALSG Law Journal, biannually.
- 4. With his attitude of **Work Hard and Play Hard**, the Law School has achieved excellence both in Academics as well as Sports and Co-curricular activities. - e. Registration by 56 teams and participation of 44 teams from renowned institutions throughout the country, manifested the reach of ALS, AUMP in the country.

- 2. A data base of all the Memorials of participants has been developed and maintained for future reference.


- 3. The guests invited will provide internships to the students of ALS.
