Who Needs to Know About This Policy	This policy governs AIHE & AGBS recruitment process of students, and the staff of Marketing and Admissions department should be aware of this policy and its implementation.
Reason for Policy / Purpose	This policy outlines the criteria and processes for selecting and admitting students to the institution by ensuring fairness and equality, diversity and inclusion.

### **Policy Purpose**

At AIHE & AGBS admissions policy is intended to set transparent and unambiguous rules and procedures for student selection and admission. The institution's essential ideas, goals, and procedures for maintaining a just, equitable, and academically sound admissions process are laid out in this policy.

### **Scope and Application of this Policy**

The scope of an admissions policy is to guarantee that the admissions processes at the institution are open, consistent, and in line with its educational objectives and core values. It seeks to uphold academic standards, advance justice and equity, and draw a qualified and diverse student body.

### **Policy Statement:**

Our goal at AMITY Mauritius is to promote a diverse and active learning environment. Our dedication to fair, open, and academically sound admission procedures is anchored by our Admissions Policy



## **POLICY FRAMEWORK**

**Equity and Inclusion:** We at AMITY Mauritius are committed to providing equitable access to higher education, ensuring that all applicants, regardless of their background, are given a fair and equal opportunity to join our academic community.

**Academic Excellence:** We maintain high academic standards, admitting students who demonstrate the knowledge, skills, and potential to excel in their chosen programs of study.

**Transparency and Clarity:** We are transparent about our admissions criteria, processes, and requirements, providing prospective students with clear, accessible information to facilitate their application.

**Compliance:** Our admissions policies and practices adhere to all applicable legal and regulatory requirements, as well as accreditation and certification standards.

**Diversity and Inclusion:** We actively seek to cultivate a diverse and inclusive student body, recognizing the value of varied perspectives and experiences in enriching the educational journey.

**Alignment with Institutional Mission:** Our admissions policy aligns with the institution's mission, vision, and educational objectives.

**Efficiency and Effectiveness:** We maintain efficient and effective admission processes to support our institutional goals and offer applicants a positive experience.

**Admission Criteria and Requirements:** We clearly define admission criteria, encompassing academic prerequisites, standardized test scores, recommendation letters, interviews, portfolios, or any additional factors specific to programs.

**Timelines and Deadlines:** We set application deadlines and notification dates, establishing a structured timeline for admission cycles.



**Financial Aid and Scholarships:** We offer opportunities for financial aid and scholarships, ensuring that applicants are aware of the available support options.

**Selection and Review Process:** We have rigorous processes for reviewing applications, including the involvement of admission committees, faculty, and staff in the selection process. Additionally, for AGBS we abide by international partners admission policy.

**Notification and Communication:** We communicate admission decisions promptly and transparently to applicants, enabling them to make informed choices.

**Waitlist and Deferral Policies:** We define policies regarding waitlists, deferrals, and related admission matters. Additionally, for AGBS we abide to international partners' deferral policy.

**Appeals and Grievances:** We have a fair procedure for addressing appeals and grievances from applicants who believe they have been treated unfairly during the admission process.

**Privacy and Data Security:** We safeguard applicant information, ensuring compliance with privacy and data security regulations.

**Continuous Improvement:** We commit to regular review and adjustment of our admissions policy to reflect changing educational and societal contexts and incorporate best practices.

Our Admissions Policy underpins our dedication to fostering an inclusive, diverse, and academically rigorous environment where students can thrive and excel. We expect all applicants and our staff to embrace and support these principles throughout the admission process.

### **Admission of Students (Current)**

Students are admitted twice per calendar year. AMITY Mauritius fully subscribe to the minimum entry requirements set by the Government of Mauritius. Additionally, prospective candidates should fulfil other qualifications required by AIHE and as required by international partners for AGBS programmes. The entry requirements to study at AIHE are as indicated hereunder.

### *Undergraduate*

- a. **For local students-** 2 A-level and 2 subsidiary or has 3 A-level and 1 subsidiary at Cambridge Higher School Certificate or 2 A-level at London GCE (as specified by the local authorities)
- b. **For international students-** Qualifications equivalent to A-level

Students applying for the AGBS programmes will abide by the international partners' requirements.

### *Postgraduate*

An undergraduate degree from a recognized Institution or equivalent acceptable to the AIHE admission requirements.

**Mature Students:** AIHE accepts applications from mature students, provided they meet the Rules and Regulations which have been defined and have obtained the appropriate minimum basic qualification requirements.

**Recognition of Prior Learning:** AIHE has a well-defined Policy of Recognition of Prior Learning (RPL), Policy of Accreditation of Prior and Experiential Learning (APEL). AIHE will accept students who have earned credits in modules either in AIHE or elsewhere, for lateral entry, subject to a case-by-case assessment of the credits earned, and the level of exemption that may be granted. Students enrolled on AGBS programmes the RPL and APEL will be in accordance to the international partners Institutions Admission policy.

### **English Language Requirements on AIHE Programmes:**

For undergraduate courses, applicants whose medium of instruction at HSC or equivalent level is not English must provide evidence of their English language proficiency. The level required for study for an undergraduate degree course is IELTS = 5.0 or its TOEFL equivalent. The requirement to provide TOEFL/IELTS score may be waived for students who's medium of instructions for the qualifying level was English.

For postgraduate courses, applicants whose medium of instruction at bachelor study or equivalent level is not English must provide evidence of their English language proficiency.

The level required for study for a post graduate degree course is IELTS = 6.5 or its TOEFL equivalent. The requirement to provide TOEFL/IELTS score may be waived for students who's medium of instructions for the qualifying level was English. Additionally, for the AGBS programmes students will abide by the Partners Institutions policy.
