The programme integrates theory with applied learning, emphasising the interdisciplinary nature of business and the role of finance in supporting organisational planning, control, and management across sectors.

ENTRY REQUIREMENTS

- Pass in Three (3) subjects at A-level at the Higher School Certificate (HSC) Examination
- OR Pass in the IGCSE and the International Baccalaureate (IB)
- OR Any Equivalent qualifications
- English Language Requirements: IELTS 6.0 (or equivalent) with a minimum of 5.5 in all bands for study at undergraduate level
- Applicants should also meet the UCAS Tariff points for entry to the programme
