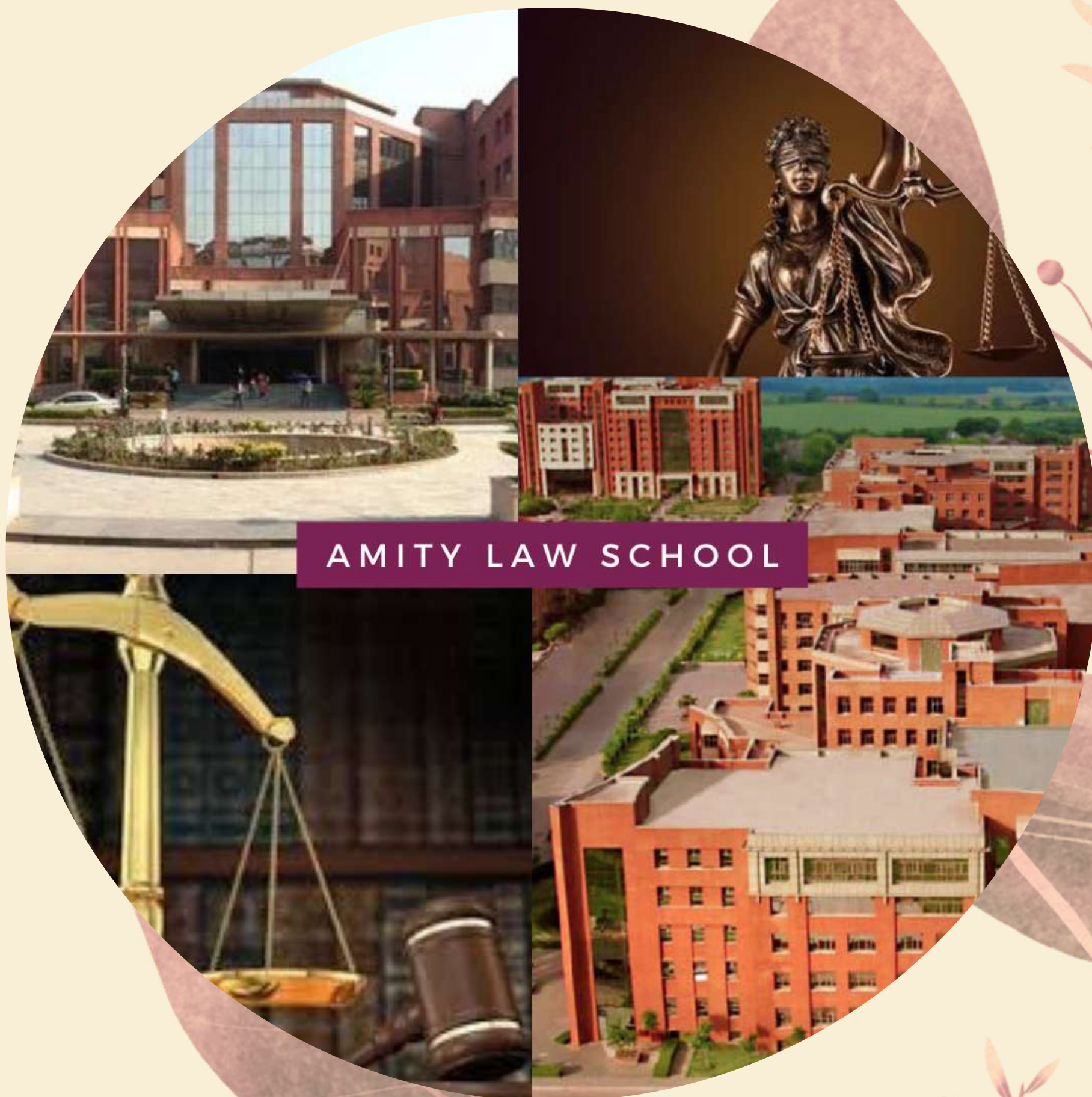

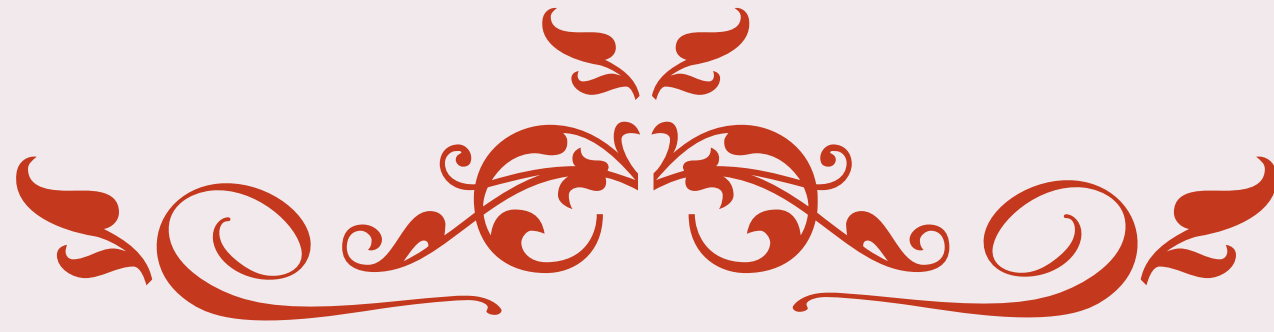

The winners of the Indian Rounds of the Philip C. Jessup International Law Moot Court Competition, 2022 were "J278 Jindal Global Law School."

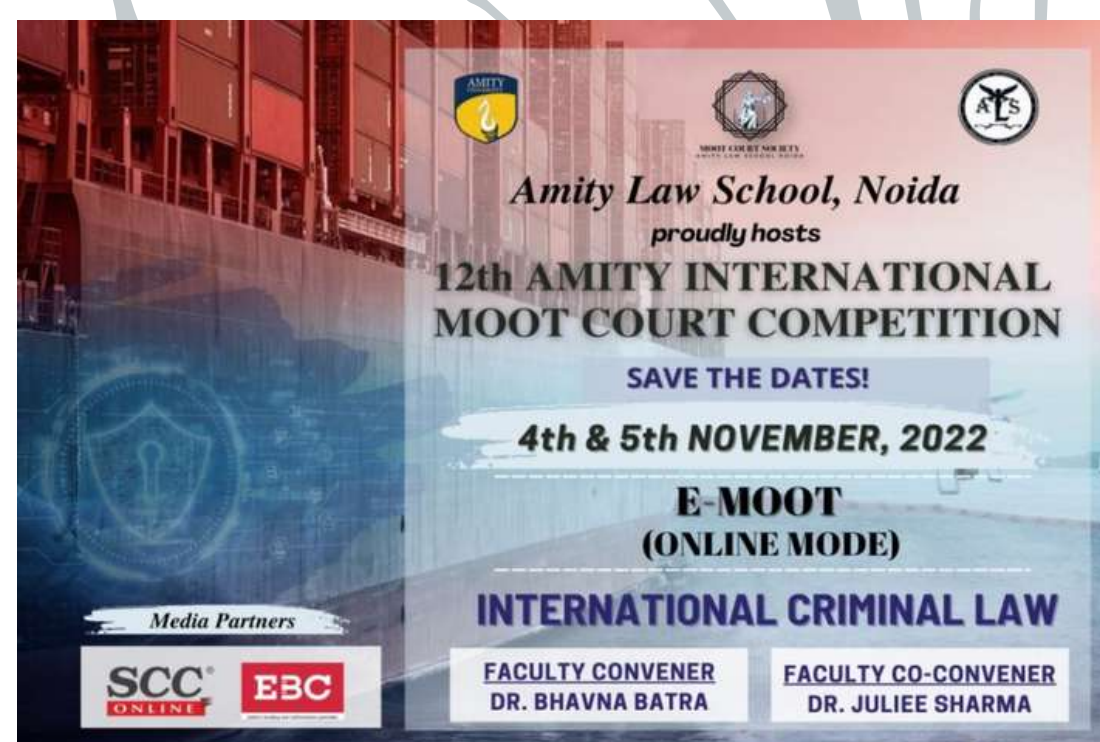
Moot Court Society is student run society to govern all Moot Court related activities like hosting and participating in Moot Court Competitions.

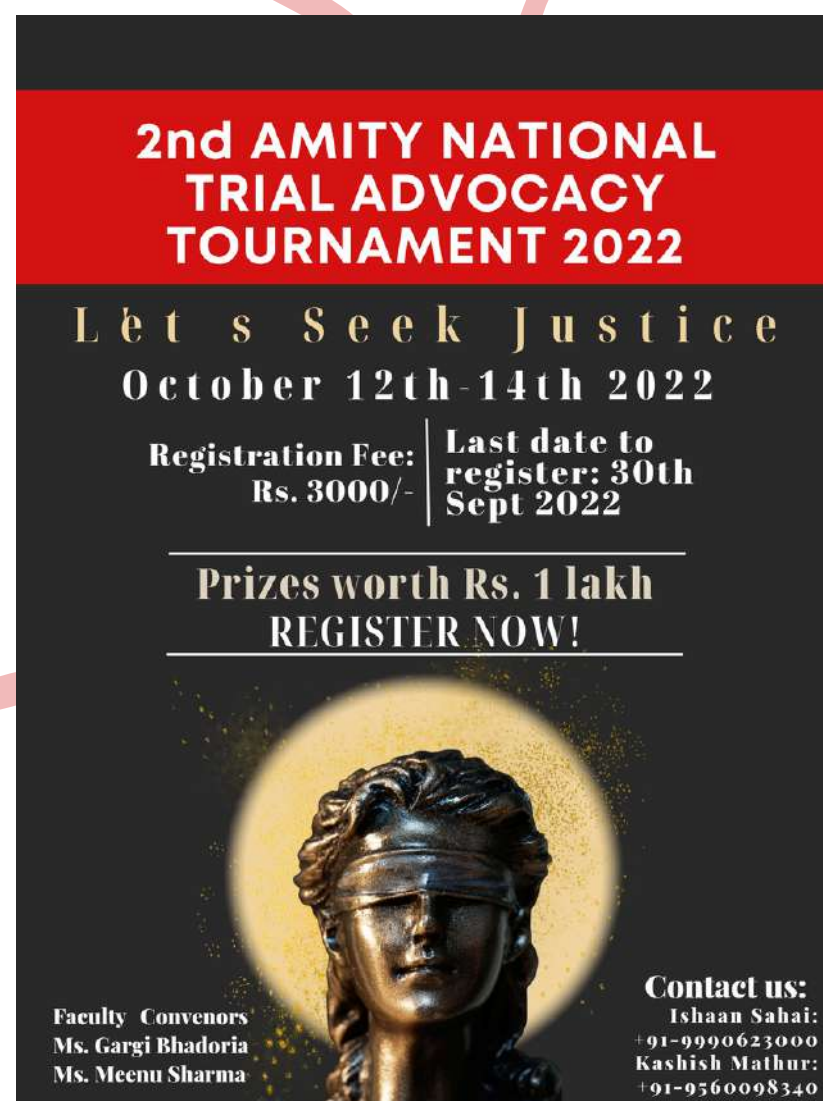
It will be a training event where we aim to sensitize students to the needs and environment of the senior members of the society who are often neglected.

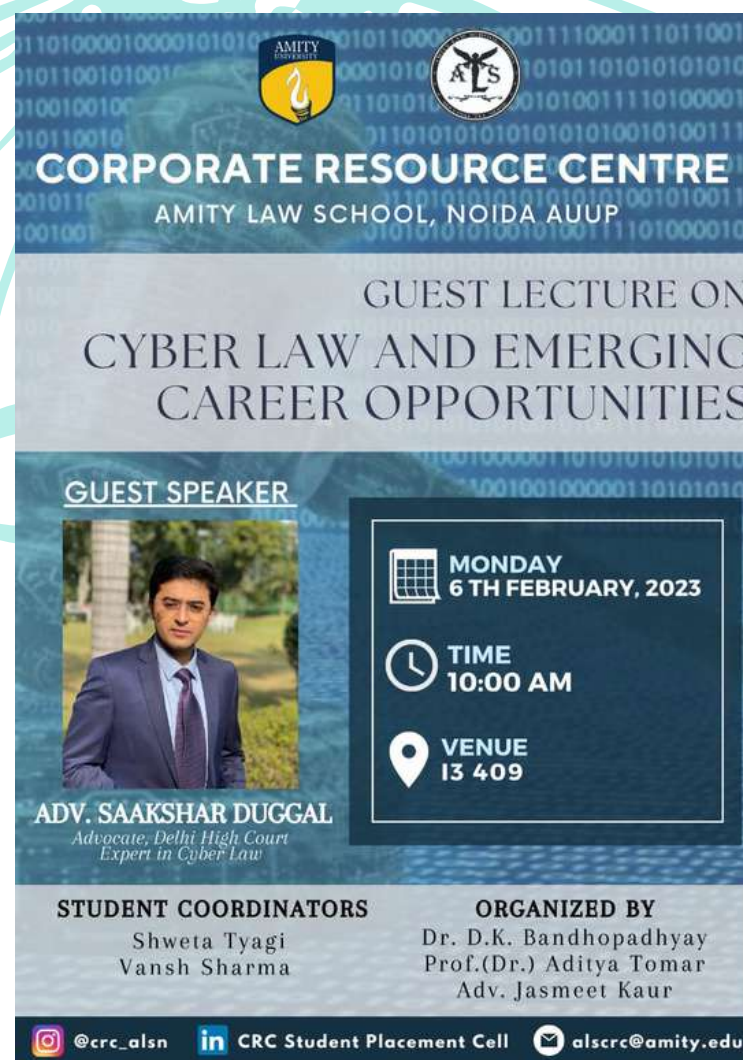


Corporate Resource Centre organised **Campus Interviews** with various law firms and corporate for the batch graduating in 2023.

Let's Break the Ice



FACULTY DEVELOPMENT PROGRAM

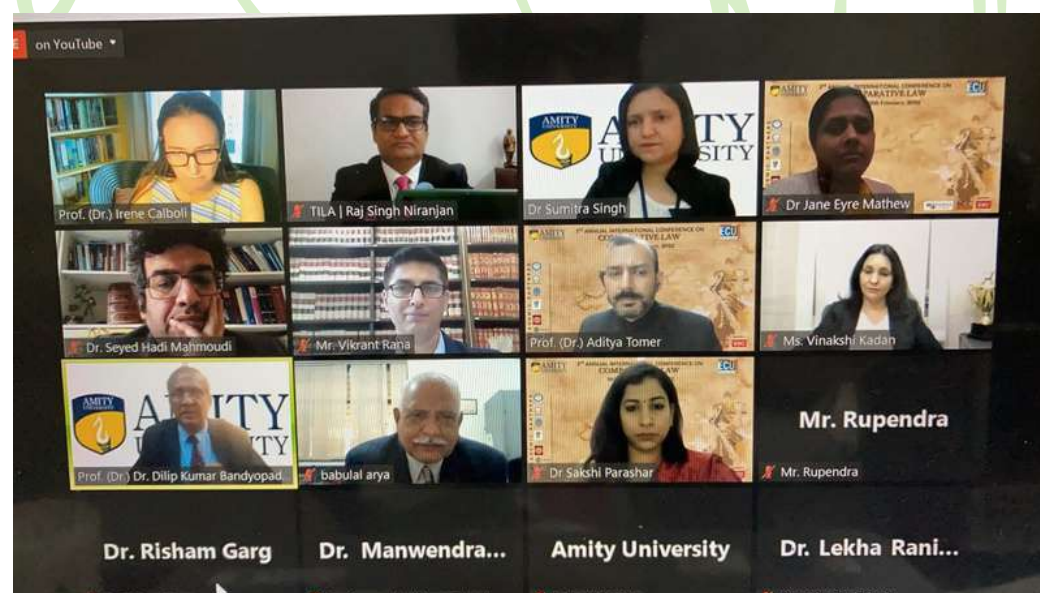
