1. Contract Engineer (Electronics) No. of posts - 2

Requirements:

- <u>Qualification</u>: First class for General and OBC Candidates and Pass Class for SC/ST candidates in BE / B.Tech (Electronics / Electronics & Communication, Electronics & Telecommunication, Telecommunication, Communication) from a recognized University/ institution.
- <u>Experience</u>: Minimum of One year hands-on experience in PCB Design.

2. Contract Engineer (Mechanical) No. of posts - 5

- <u>Qualification</u>: First class for General and OBC Candidates and Pass Class for SC/ST candidates in BE/B.Tech (Mechanical) from a recognized University/ institution.
- <u>Experience</u>: Minimum of one year hands-on experience in Product Design for defence application. Preference will be given to candidates with experience in 3D modeling, design verification by carrying out structural and thermal analysis, prototyping, design validation and engineering documentation. Knowledge in SAP will be an added advantage.

General requirements:

- <u>Age:</u> 25 Yrs and less as on 01.06.2016
- Reservation & Relaxation to SC/ST/OBC candidates will be as per Govt. rules.
- <u>Remuneration:</u> An all-inclusive consolidated remuneration of Rs. 18,000/- per month.
- <u>Period of contract</u>: **One** year from the date of joining, however the same may be extended depending on the progress of the project and performance of the candidate.

Method of Selection: Eligible candidates, who satisfy the above conditions, will be called for written test (objective type questions in above disciplines) followed by an interview.

• Candidates are required to produce all original certificates, a copy of each of them and a recent passport size colour photograph, on the day of the written test/ interview.



- Candidates who have not completed BE/B Tech. need not apply. Those who are unable to produce their Degree marks cards and certificates in original on the day of the written test/interview for whatever reason will not be considered.
- Candidates belonging to reserved category i.e. SC/ST/OBC must submit copy of caste certificate as per the format prescribed by the Government of India on the day of Written Test/ Interview.
- Local candidates will be preferred. Only Indian Nationals need to apply.
- Candidates shortlisted for the test will be informed through e-mail/SMS regarding the date of written test & interview. Candidate can also download call letter after logging to the portal using the userid. Any correspondence with the candidates will be through e-mail only. BEL is not responsible for any problem related to e-mail correspondence.
- If there are more eligible applicants, the number of candidates to be called will be restricted in proportion to the requirement based on academic excellence, experience, age etc.

Eligible candidates are required to apply online only through BEL's website <u>www.bel-india.com</u> (Recruitment section): No other means/mode of application will be accepted.


Before registering the applications at BEL website the candidates should possess Valid e-mail id and mobile no, which should remain valid & active till the completion of selection process:

- 1. Candidate can access the online application form at <u>www.bel-india.com</u>. The online registration site would be open from **29th June**, **2016 to 20th July**, **2016**.
- 2. No changes shall be allowed once the candidate has saved and submitted his/her application.

There are two steps of submitting the application at the portal:

Step-1: Registration: This involves filling the preliminary application and submitting it. The successful submission at the portal will provide you the user id and a link to login and fill the detailed application form.

Important: Make a note of the user-id that the system will provide you as a display on the screen after successful completion of the step-1. (User Id and link will also be sent to mail id furnished by you during the registration)



<u>Step-2: Filling the detailed application form</u>: Login through user-id provided to you by the portal (i.e. after successful completion of step-1) and then fill the detailed application form.
