



## Q. Features and Highlights of SAP

A. Study Abroad Programme (SAP) is important for global exposure of students of various disciplines. The SAP programme has been re-engineered to give an experiential learning platform to the students of Amity on a global scale. The students will get hands-on experience of gaining knowledge of foreign culture, industry and economic dynamics. It will provide the students with an opportunity to interact with foreign faculty and carry out focused projects under their expert guidance.

#### SAP is offered in two modes:

- **Inclusive SAP**: Inclusive SAP will be offered in programmes where the academic fee includes fee for one SAP.
- Optional SAP: Optional SAP will be open to all programmes where students can opt for SAP and pay fees for the same as per approved Model Framework.

In this program, students gain a unique exposure through studying and exploring for five weeks at any of the six destinations namely UK, US, Singapore, Dubai, Australia and France. Students get 8-12 credits as per their academic mapping for successfully completing the SAP Programme.

Amity has a growing network of campuses and partnerships across the world and may add more destinations to give a wider choice to the SAP Global explorers.

## Q. How to apply for SAP?

A.

- Students apply for SAP to their respective HOI through their programme coordinator.
- Pay the fees of the selected SAP destination
- Student's APW will be approved by HoI on AMIZONE as per model framework.
- Student's selection to be recommended by the Course Advisory Committee and approved by HOI.
- Upload soft copy of required SAP documents in your AMIZONE.
- Submit hard copy of all SAP documents to your SAP Coordination / Programme Leader
- IAD will assist the HoIs / HODs, Students and faculty in Visa Application process, logistics arrangement and other itineraries

## Q. What are the documents required for SAP Application

A. The students have to upload the following forms on their Amizone (SAP-Upload Documents) and also submit to their respective ProgrammeCoordinator/Programme Leader: -

- 1. SAP Application Form (Annexure A) for Singapore, Dubai, Australia, France Canada & USA
- 2. Indemnity Bond on a Rs.100/- stamp paper, notarized and signed by their parents.(Annexure B). To be filled by students opting for Amity Accommodation
- 3. **Undertaking on a Rs.100/- stamp paper,** notarized and signed by themselves.
